Unexpected Storage Tank Rehab Fuels Need for Water Rate Increase

SPRING 2021

As many may already be aware, the ground storage tank at Water Plant #1 (behind the FAVCC Golf Course) was taken out of service on January 18th for minor welding repairs, necessitating the draining of the tank and the need for switching to Fayette Water Supply Corporation's water. The District planned to make use of the time that the storage and pressure tanks would be out of service, by making arrangements to have both tanks cleaned and inspected, inside and out. On January 19th, after the cleaning of the storage tank, it was discovered that the floor of the tank had severe pitting and would require extensive repair/refurbishment, or even replacement, in order to be returned to service.

At the February 11th board meeting, Mr. Bradley Loehr, of BEFCO Engineering, presented several options for refurbishment and replacement of the existing galvanized, bolted ground storage tank. The most cost effective and time sensitive option was to refurbish the existing carbon steel ground storage tank with a new steel floor, to sandblast and coat the interior with a product called Reactamine, thus extending the life of the storage tank by a projected 15-20 years. Since the District had already been planning on making some needed repairs to the pressure tank within the next year or two, also included in the scope of work was the replacement of the pressure tank manway, and sandblasting/recoating the interior and exterior of the pressure tank. CFG Industries submitted the lowest bid of \$130,950 and was awarded the project, with an anticipated completion date of April 23rd.

Due to the urgency of getting the project started, and completed, it was not feasible for the Board to sell some of the remaining bonds from the 2016 voter approved bond election, just as it was not in the best interest of the District to deplete the funds in the Operating Fund account. The board voted to obtain financing from Government Capital Corporation in the amount of \$153,000 (which includes a \$3,000 issuance cost) at an estimated rate of 2.25% with 5 annual estimated payments of \$32,696.13 and which carries no pre-payment penalty.

After much deliberation, the board determined a water base rate increase would need to occur this coming fiscal year, which begins April 1st. The increase would secure enough annual revenue to meet the financing commitment for the refurbishment of the storage and pressure tank at Water Plant #1, as well as fund non-bond related capital improvements such as the also needed ground storage tank and pressure tank \longrightarrow

refurbishment/replacement at Water Plant #2, sewer and water line replacements needed throughout the District, in addition to providing funds for normal operation expenses, which are expected to increase due to the rising cost of labor and materials. Several different rates were discussed. The rates voted on and approved by the board can be found below, including a comparison to the current water base rates:

Sewer rates will also be increasing, as shown in the chart below, due to an increase in sewer rates adopted by La Grange Utilities annually in November, and then charged to the District.

The District is aware that its rates are higher in comparison to other water providers in the area. This is due in large part to only having approximately 230 customers to incur the repair and improvement costs of an aging infrastructure that is currently in need of substantial repairs. Larger providers can divide these costs among many customers instead of a few, such as Fayette Water Supply Corporation with an estimated 2,450 customers, La Grange Utilities with an estimated 2,500 customers, and Lee County with an estimated 4,145 customers. While the District has an Interconnect Agreement with Fayette Water Supply Corporation for the selling of water to the District in emergency situations, or during periods of planned maintenance and repairs, at a rate of \$3.20 per 1,000 gallons of water, there are currently no alternate, permanent providers of water and/or waste-water service available to the District.

Please remember, the Board does not arbitrarily make impactful financial decisions without guidance from the District's financial advisor, legal counsel, and the Texas Commission on Environmental Quality. Any decision the Board makes, which impacts customers, impacts the board members, as they, too, reside within the water district, and therefore, pay the exact same water and sewer rates, and property taxes, as everyone else in the water district.

The Board encourages members to attend the monthly board meetings, held on the 2nd Thursday of every month at 4:00 p.m. at the Fayette County WCID-Monument Hill District Office located at 100 Country Club Dr. The Board is always willing to answer any questions, or listen to voiced concerns, during the Public Comments portion of the meeting. The new rates will become **effective April 1, 2021** and will be reflected on the bills received at the end of April/beginning of May.
