The Board is pleased to welcome John Etue who was elected to the MHPOA Board of Directors at the Annual Meeting in July. John will be serving as the new Restrictions Director, replacing Darlene Gilmore, whose 2-year term concluded in July. In August, Theresa Avera, was appointed to the Board to fill the remaining one-year term left by Brenda Benes' resignation due to her and husband James relocating to Gonzales, Texas. Theresa will be serving as the new Treasurer. The Board thanks both Brenda and Darlene for the time they've devoted to serving their community over the many years they've lived within the Association. Their knowledge of the past history of the POA was second to none and they will be missed on the board.

If you haven't driven around the neighborhood lately, I urge you to check out the newly re-furbished Bluff Haven entrances on Park Drive at Molly Drive and at Chris Court. Also, on the corner of Country Club Drive at Richard Road, a new brick entrance was installed on the west corner. The original brick structure located on that corner was removed several years ago after a tree had damaged one of the brick columns, rendering it irreparable. New "Bluff Haven" signs, including a backlit sign next to the office, and entry lighting adorn the recently resurfaced brick columns and have really spruced up the area. We have been trying hard to update the entrances and bring it back to a state that we can all be proud of as we drive in and out of our community. Colter Zoch, who maintains the esplanades for the Association, has also worked to keep the flower beds and the areas around the entrances eye appealing and inviting. We will be finishing this project in the spring with new plants to fill the vacant spots in the beds.

I am excited to announce that there is finally progress on the homes that were affected by the flooding as a result of Hurricane Harvey. I want to make it clear to several that have expressed frustration on this that the POA Board has been continuously pursuing this for the past two years when it was noticed that the plans were at a standstill. Although it looked as if there was nothing happening, questions and pressure to act was being sent to the county from the POA. In this process, there was only so



Attendance at our Annual Meeting in July was dramatically down from 2019, with (6) MHPOA members present.

Mark Hermes reported three directors would need to be elected. Both he and Cleo Schneider had volunteered to serve another term, leaving one vacancy to fill. The Association received two write-in candidates of John Etue and Charles Mazac. Mark Hermes and Cleo Schneider each received 18 votes and 19.5 proxy votes, for a total of 37.5 votes and were unanimously re-elected for a two year term. Mr. John Etue received 9 votes and 19.5 proxy votes for a total of 28.5 votes. Mr. Mazac received 1 vote. John Etue was elected to the MHPOA Board of Directors for a two year term.

Brenda Benes reported that the Association's total

Cash Assets were \$43,439.19, a change of <\$\$11,031.17 > from July 2019. Delinquent accounts totaled approximately \$1,000.

Cleo Schneider reported that the Deer Committee would be conducting two deer counts during the month of August. Those counts would be reported to TPWD and would determine how many doe permits the Association will receive.

Recently, on September 10<sup>th</sup>, Grant Works, the company in charge of the buyouts, presented at the Commissioner's Court meeting and a plan is in place. This plan, if it continues on schedule, could be completed by the end of the year and we could see demolition taking place in early to mid 2021. This is welcomed news to everyone, especially the families that have lost so much. We should continue to keep them in our prayers as they close a chapter in their own books. Let us remember that they are the ones that have endured so much, and we hope for the best as they move on with their lives.
