Have you ever wondered what criteria the Yard of the Month Committee takes into consideration? Here's a quick run down:

- A well kept yard and trimmed shrubs (given the persistent drought conditions, a perfectly green yard is not mandatory)
- All pots have plants in them (remove empty pots)
- A neat front porch and patio area
- No cars or trailers parked in the yard (or any other visible violation of the deed restrictions)
- Property owner must be current on their POA dues

Please note that yards are not judged on a one time drive around the neighborhood. All properties are repeatedly assessed throughout the month.

## A Few Reminders..

- No parking of vehicles, boats, RVs, trailers, etc. is allowed in the grass or overnight on the street.
- Do NOT feed the deer.
- All pets should be confined to your home and/or yard, or be on leashes. Barking dogs outside should be brought inside or quieted.
- Trash cans should be put away after trash pick up day.
- Unsightly storage of any kind is not allowed, and should be put away.
- No Parking on the street, or grass, or any unpaved areas is allowed. Illegally parked vehicles can and will be towed
- No loud music, so as to bother your neighbors, is permitted at any times.
- Always be respectful of your neighbors & their property.
