Your MHPOA Board has remained active. We have worked diligently with the Fayette County Sheriff's Department in speed enforcement along Country Club Drive and Park Drive. We also coordinated with the Sheriff's Department for additional security during the aftermath of hurricane Harvey. And we supported our County Commissioner's efforts to improve the roadways in our communities. Harvey Berckenhoff initiated area repaving with work in Frisch Auf and has advised us that he will support additional repaving of roadways in our neighborhoods over the next several years. We also initiated an esplanade clean-up program to help make these attractive features look a little more manicured.

Our Deer committee completed last year's deer reduction efforts successfully and we have initiated the reduction efforts for the 2017-2018 season. A report from the Deer committee is enclosed.

And this year, we formed a Deed Restrictions committee to evaluate and propose beneficial changes to our General Restrictions that could enhance the quality of life here. Sylvie Armstrong is chairing this committee and has provided a brief update in this newsletter.

Your MHPOA's finances remain in good order. We ask that you share your thoughts about how the Board can continue to serve our community using the funds you have provided for maintenance and beautification of our neighborhoods.

Deed Restriction Review

The Deed Restrictions Committee has been formed and is underway with reviews of the existing restrictions and any needs for additions, updates or deletions. Your neighbors participating on this committee include: Sylvie Armstrong (chairperson), Fritzi Kulhanek, Mark Hermes, David Tauch and Gary Kramer.

We got off to a delayed start due to hurricane Harvey and related activities. The committee has met twice and expects to have one more meeting by the end of 2017. We have taken the 2017 Annual Survey responses from property owners and carefully reviewed them to help guide our activities and focus for meeting the needs of our community.

If any of you have suggestions for changes to our deed restrictions, please feel free to call any of this committee's members.

Deer Committee Apdate

The Deer Committee continues to monitor the number of deer present in the neighborhood. The group is chaired by Bill Keating who is assisted by Nora Butler, Bradley Loehr, David Tauch, Wes Gilmore, Cleo Schneider, and Mike Wallace. Activities of the committee since the last newsletter include finalizing the late summer deer count and submitting the information to TPWD for analysis and recommendations aimed at controlling the number of deer living around us to a more healthy level.

The counting effort this summer was interrupted by hurricane Harvey. On August 18th our initial survey indicated there were 117 deer in our bluff area. This count included the residential areas and the golf course. Following the August 25th hurricane, 92 deer were observed in the same area.

The information gathered in the surveys was forwarded to TPWD for review. As a result of their analysis, 60 MLD doe tags were issued to the MHPOA deer committee. These permits are good through the current hunting season which lasts until the end of February, 2018.

The Deer Committee would like to thank all who are continuing to avoid feeding these wild animals. Benefits of maintaining a lower number of deer in the area herd include:

1) Lyme disease control, 2) garden damage reduction, 3) healthier deer, and 4) public safety.

Treasurer's Report

Our checking and savings account balances for 12/1/2017 respectively are \$31,425.97 and \$25,291.68 for a total of \$56,717.65. Our accounts this same time last year were \$24,036.73 and \$25,000.00 for a total of \$49,036.73. Our annual increase is \$7,680.92. Our \$25,000 CD earning 1.16% at Fayetteville Bank was rolled over on June 15 for another 12 month term at 1.19% interest. Our total past due accounts receivable balance on 12/1/2017 was \$1,225.88 compared to \$365.21 the same time last year. Please pay your quarterly dues in a timely manner.
